

2007 Trucks with 2006 or older engine/exhaust

Age Exception Application

1. Introduction

Pursuant to the April 6, 2016 notice regarding 2007 trucks with 2006 or older engine/exhaust, please note that this application form is only for those 2007 trucks with 2006 or older engine/exhaust, and must be completed by the Access Agreement holder, for both company trucks AND trucks owned or leased by Independent Operators within the Access Agreement holder's fleet of drivers.

Please complete all sections. Print neatly in black or blue pen, and include all required documentation. Incomplete and/or illegible forms will not be considered. Be advised that completion and submission of this form and any supporting documents does not guarantee that this truck will be granted an age exception for 2016.

A decision will be made within several weeks of the receipt of the completed forms and supporting documentation. You will be informed of the final decision via email from TLS Administrator. If you are applying on behalf of an Independent Operator who forms part of your fleet, it is your obligation to confirm the information supplied to you by the Independent Operator is accurate and complete, and to advise that Independent Operator of the status of this application.

- **An APPROVED age exception for 2007 trucks with 2006 or older engine/exhaust is required to continue accessing the port.**
- **The TLS Administrator will accept ONLY duly completed age exception applications received by e-mail.**
- **The TLS Administrator will accept ONLY duly completed age exception applications for 2007 trucks with 2006 or older engine/exhaust through July 31, 2016.**
- **Please note that it takes on average 4-12 weeks after ordering for an appropriate DOC to be available for installation, where not in stock already. Deposits for DOC orders will not be accepted. It is recommended you factor order and delivery time into your application process.**
- **Please note it can take several weeks to process an application for approval. It is recommended you submit your application as soon as possible.**

2.4 Emission Reduction Measures (ERMs)

- ERMs must be currently or formerly verified by one or both of the California Air Resources Board (CARB) or the U.S. Environmental Protection Agency (EPA), for on-road vehicles and for the specific truck/engine/exhaust system for which an Age Exception is being sought, unless otherwise noted below. *It does not include technologies formerly conditionally verified or technologies never verified, by either agency.*
