## **Introduction**

The role of the Vancouver Fraser Port Authority (“VFPA”) is to facilitate and expand the movement of cargo and passengers through the Port of Vancouver; administer the north and middle arms, and lower portion of the main arm of the Fraser River; provide facilities, services and technologies that are competitive, safe, commercially viable, dependable, environmentally responsible and customer oriented and to operate with broad public support in the best interests of Canadians.

The purpose of the *Access to Information Act* is to provide the public a right of access to information to records under the control of a government institution, that necessary exceptions to the right of access should be limited and specific and that decisions on the disclosure of government information should be reviewed independently of government.

The Annual Report is prepared for and tabled in Parliament in accordance with Section 72 of the *Access to Information Act*.

The mandate of the VFPA is to comply with the *Access to Information Act*, the principles of open government from which it is derived and for making any required decisions.

## **Vancouver Fraser Port Authority ATIP Office Organization Structure**

Written or email access requests are directed to the ATIP Coordinator, who processes the application fee, opens a file and coordinates the duties imposed by the legislation. The ATIP Coordinator maintains this system to account for all deliberations and decisions taken concerning each request.

## **Statistics & Interpretation of Statistics**

The VFPA received nine requests during the reporting period April 1, 2014 to March 31, 2015. There were three outstanding requests from the previous reporting period. None of the requests for the current reporting period have been carried over to the next reporting period.

The requests received and completed during the year originated from four of the five source categories: Media, Business (Private Sector), Organization and Public.

Attached is the Form TBS/SCT 350-62 “Statistical Report on the Access to Information Act,” which provides statistical data on formal access requests received by the VFPA.

Of the twelve requests that were completed during the reporting period, three were disclosed in full, seven were disclosed in part, there was one where no records existed and one was transferred. There were four exemptions invoked based on subsections 18 (b) and 19(1), three exemptions invoked based on subsection 18(a), two exemptions

invoked based on subsections 20(1), (b) and 23, and one exemption invoked based on each of subsections 16(2), 20(1)(c), 20(1)(d), 21(1)(a), 21(1)(b) and 21(1)(d) of the *Act*.  
**Access to Information-Related Education & Training Activities by ATIP Staff**

The ATIP Coordinator provided *Access to Information Act* training (orientation and awareness) to nine VFPA internal departments totaling 119 employees during the reporting period.

### **Overview of New and/or Revised Institutional Access to Information Act-related Policies & Procedures Implemented**

There were no new and/or revised policies and procedures implemented during the reporting period.

### **Complaints and/or Investigations**

There were two unresolved *Access to Information Act* complaints from the previous reporting period. One complaint was abandoned and the second concerning improperly applied exemptions remains unresolved. There was one complaint registered with the Information Commissioner during this reporting period concerning photocopying charges being assessed. The Office of the Information Commissioner found in the complainant's favor which resulted in VFPA releasing the records to the complainant without charge.

### **Monitoring of Processing Time of Access to Information Requests**

There was no monitoring conducted during the reporting period.
