Introduction

The role of the Vancouver Fraser Port Authority (“VFPA”) is to facilitate and expand the movement of cargo and passengers through the Port of Vancouver; administer the north and middle arms, and lower portion of the main arm of the Fraser River; provide facilities, services and technologies that are competitive, safe, commercially viable, dependable, environmentally responsible and customer oriented and to operate with broad public support in the best interests of Canadians.

The purpose of the *Privacy Act* is to extend the present laws of Canada that protect the privacy of individuals with respect to personal information about themselves held by a government institution and that provide individuals with a right of access to that information.

The Annual Report is prepared for and tabled in Parliament in accordance with section 72 of the *Privacy Act*.

The mandate of the VFPA is to comply with the *Privacy Act*, the principles of open government from which it is derived and for making any required decisions.

VFPA is also mandated to protect the privacy of individuals with respect to their personal information held by government and provides individuals with a right of access to such information based on the principles that:

- the collection and use of personal information is essential to the performance of many federal government activities and programs; but that
- individuals have the right to a reasonable expectation of privacy, including a basic right to exercise control over their own personal information; and
- public confidence in the government’s management of personal information is necessary to the public trust in, and support of, government programs.

Vancouver Fraser Port Authority ATIP Office Organization Structure

Written or email *Privacy Act* requests are directed to the ATIP Coordinator, who opens a file and coordinates the duties imposed by the legislation. The ATIP Coordinator maintains this system to account for all deliberations and decisions taken concerning each request.

Statistical Report

Attached is the Form TBS/SCT 350-63 “Report on the Privacy Act,” which provides statistical data on formal privacy requests received by the VFPA.

There was one request during the reporting period April 1, 2014 to March 31, 2015.

Interpretation of Statistical Report

There was no personal information on the individual who submitted the request.

There was no training provided during the reporting period.

Overview of New and/or Revised Institutional Privacy Act-related Policies & Procedures Implemented

There were no new or revised institutional *Privacy Act*-related policies or procedures implemented in the reporting period.

Privacy Complaints, Audits and Investigations

There was one privacy complaint received during the reporting period. This was a complaint regarding a recently installed CCTV camera on VFPA property that the complainant presumed was or could be directed at her residence.

The camera's fixed position is a VFPA gate entrance and only in event of an incident would the camera be taken out of its fixed position. VFPA installed a shield on the camera mount so that in the event the camera is taken out of its fixed position and inadvertently panned to the complainant's building, only a black box would be seen.

There was no monitoring conducted during the reporting period.

Privacy Breaches

There were no material privacy breaches that occurred during the reporting period.
