FRASER RIVER CONSTRUCTION SCHEDULE UPDATE

March 30, 2021

As you may know, construction of the Annacis Island Wastewater Treatment Plant Outfall is underway. This project is one of several upgrades that will allow the plant to meet the needs of our growing population, strengthen its ability to operate in the event of an earthquake, and adapt to climate change. These upgrades will ensure the continued protection of public health and the environment.

Schedule Update & Hours of Work

In order to complete this work safely and maintain the construction schedule, diesel impact pile driving within the Fraser River is expected to continue until summer 2021 during the following allowable work hours:

- Monday to Friday between 7 a.m. and 7 p.m.
- Saturdays between 9 a.m. and 5 p.m.

Please note, river conditions and flow rates may impact the work schedule. All work will comply with City of Delta and Vancouver Fraser Port Authority bylaws and permit variances.

Construction activities that will not have a significant impact on surrounding communities will resume 24 hours a day, seven days a week, as needed, on April 15, 2021, until February 2022. Anticipated activities will include:

- Concrete pours
- Welding
- Cleaning out piles
- Vibratory sheet extraction
- Equipment maintenance

Noise Impacts & Our Commitment to You


