What to expect this month

Road work

Periods of single-lane alternating traffic will continue on port roads. Current status of port road access:



- All semi-trailer and commercial vehicles must continue to enter at Commissioner Street
- Commissioner Street: Single lane alternating traffic during work hours and two-way traffic during non-work hours, Sundays and statutory holidays. October 28, 2019 to February 2020

Clark Drive overpass:

- Closed to semi-trailer and container trucks until July 2020
- Starting Monday, January 20, port pass holders with commercial straight trucks can enter the port using the Clark Drive overpass
- Open to port pass holders driving standard vehicles

Marine work

We will continue to dredge and infill to create the new land for the terminal. This work will take place 24 hours a day, 7 days a week so that we can get it done within the window of time in which fish are least impacted.

On-terminal work

On the night of January 15, 2020, from 8:00 p.m. to midnight, crews will be conducting work on the terminal. Noise and light impacts will be low.

Building new land



It can be hard to see what's going on around Centerm from the shore. [This flyover video](#) shows the work to date from the air. Since October, we've removed the mooring dolphin, created a dyke and started to fill in the area to the east of Centerm to create new land.

Second application period now open for the Centerm Community Fund

As part of Centerm Expansion Project the port authority, in collaboration with Centerm container terminal operator DP World, created a \$500,000 fund to provide support for projects and programs run by organizations in the Downtown Eastside, Strathcona, Hastings-Sunrise, and Grandview-Woodlands.



During the first intake period, we received a large number of applications and selected 16 organizations in the Downtown Eastside that will receive funding for their projects. The selection committee chose a variety of programs that support a wide range of the population including children, Indigenous community, fathers, mothers, elderly, the unemployed, volunteers and newcomers to Canada.

The second intake period is now open.

Applications can be submitted between now and April 3, 2020, and must be received during the intake period to be considered.

About the projects

The port authority is building the Centerm Expansion Project and South Shore Access Project to help meet anticipated near-term demand for containers shipped through the Port of Vancouver. The project includes a new overpass for Centennial Road, making Waterfront Road a continuous road along the South Shore, and a reconfiguration and expansion of the Centerm terminal.

The projects, delivered by Centennial Expansion Partners (CXP), are set to be complete by the end of 2021.
