About the project

The Commissioner Street Road and Rail Realignment Project is underway in coordination with Canadian Pacific Railway (CP) to help increase the cargo capacity of port terminals on the south shore of Burrard Inlet in preparation for growth of Canadian trade. The project includes:

- Removing the old Columbia Containers grain silo (complete)
- Building new retaining walls
- Relocating and building new utilities
- Realigning Commissioner Street and adding traffic lanes near Columbia Containers to improve traffic flow
- Installing additional rail track (led by CP) to increase rail capacity



These improvements will:

- Improve port truck movements and traffic flows
- Improve access to terminal facilities for commercial traffic
- Enable safe and efficient access to port lands for employees and service providers
- Provide land for rail track expansion, supporting trade growth and more local and national jobs

As part of the project, the port authority purchased the old Columbia Containers grain silo and demolished it in early 2020. The road realignment component work is scheduled to begin in February 2021, with project completion expected in spring 2022. The rail work is scheduled to begin in early 2022 and is expected to be completed by late 2023/early 2024.

The project is funded by the port authority and the Government of Canada through the [National Trade Corridors Fund](#).

About the permit amendment request

The request to conduct some construction activities outside of regular work hours requires an amendment to the project's construction permit. This request was submitted through the port authority's Project and Environmental Review process at the end of November 2020.

The amendment to the project permit is required because construction of this project is within the corridor impacted by the construction activities for the Centerm Expansion Project and South Shore Access Project. The area is narrow and complex, presenting a number of challenges for construction and users of port roads. To address these challenges, the project construction team needs to be able to work during extended hours and on Sundays.

Construction activities

If the permit amendment request is approved, night works will take place mainly in the eastern half of the project (along Commissioner Street, north of the CP tracks, between Slocan Street and Renfrew Street). Other works that will take place include underground utility work, overhead and underground infrastructure installations, electrical work, retaining wall construction and asphalt paving, as well as sanitary sewer relocation.

The permit amendment request was to allow some construction between 8:00 p.m. and 7:00 a.m., Monday to Sunday, from February to July 2021, as needed. During this period, we expect the work will generate noise and some light from the project site, so we will implement noise and light reduction measures, including the following:

- Shrouding stationary equipment to contain the noise
- Conducting activities that may result in more noise, such as excavation using a vacuum truck (hydrovac), in the early hours of the night shift (5:00 to 8:00 p.m.)
- Facing lights on construction site away from residences
- Using silent pumps during the bypass pumping for Metro Vancouver sanitary sewer relocation activities
- Ensuring all noticeable noise (such as white noise back up beepers on equipment) is well within 70 dBA as per WorkSafeBC construction guidelines

Project and Environmental Review requirements

As part of its review process, and following the recommendation from the East Vancouver Port Lands committee, the port authority requested that the project team provide additional notification to residents and businesses in the project area, as well as give the public an opportunity to offer feedback on the permit amendment request.

Feedback on the permit amendment request was submitted directly to the port authority through our community feedback line (community.feedback@portvancouver.com) between December 14, 2020 and January 6, 2021.

Impact Assessment Registry notice requirements

As required by the *Impact Assessment Act* and the PER process, the port authority posted a notice of intent to the Canadian Impact Assessment Registry on November 27, 2020.

The public was also able to submit feedback through the [Canadian Impact Assessment Registry website](#) until December 26, 2020. No comments were submitted from the public during this period.

Summary of engagement

In support of the permit amendment request, the project team undertook engagement with and notification to residents living in close proximity to the project, in particular residents of Burrardview. The feedback gathered through this engagement process is summarized below and will be used to inform the construction management plan, should the amendment be approved.

Level of public participation

Based on our understanding of community concerns, the project team determined that the level of engagement for this permit amendment request is “consult” on the [International Association for Public Participation](#) (IAP2) spectrum of public participation. Under the “consult” category, the IAP2 endeavors to keep the public informed, listen to and acknowledge concerns and aspirations, and provide feedback on how public input influenced the decision.

Liaison committee engagement

Two virtual meetings were held in early December 2020 to engage port authority community liaison committees in the project area. The purpose of the meetings was to provide an update on the project, including information on the permit amendment request and how to provide feedback.

- **South Shore Community Liaison Committee (SSCLC):** On December 1, 2020, the project team provided an update on the project, including advance notice of the construction commencing and the amendment request under review.

- **East Vancouver Port Lands (EVPL) committee:** On December 8, 2020, the project team provided an update on the project and sought input from the committee on the construction management plan and notification to residents.

Public comment period

Between December 14, 2020 and January 6, 2021, the port authority held a public comment period for the permit amendment request for the project. The public was invited to share feedback by emailing or calling the port authority through the community feedback line.

A total of nine responses were received during the public comment period. All public comments were from residents on Wall Street in Vancouver, B.C.

Feedback from residents related to noise and light impacts, timing of consultation, and project timing and duration. Residents also provided feedback on railway activity, which falls outside of the port authority's jurisdiction. See the table below outlining all concerns, and the project team's responses to topics raised.

No public feedback was received on the Impact Assessment Registry website.

Notification activities

On December 14, 2020, notification letters were hand delivered to 250 residents in the Burrardview area, including building complexes in the designated notification area (see **Appendix A**). The notification letter can be found in **Appendix B** and included the following information:

- Overview of the project
- Area map or other renderings/images (with labels) showing the location of the work
- General timelines and work hours
- Amendment request and the project need
- Potential construction impacts and mitigations (noise, light, dust, traffic)
- How to provide feedback and how it will be used
- Contact information
- Link to the project webpage
- Link to sign up to new project newsletter

Because of the close proximity to the Centerm Expansion Project and South Shore Access Project, the project also provided notification of the permit amendment request in the December 2020 Centerm Expansion Project [newsletter](#). This newsletter is sent monthly to 548 recipients, is posted to the project website and was distributed to both the South Shore Community Liaison Committee and the East Vancouver Port Lands committee.

Project website

The project website page was updated to include information on the permit amendment, including the following:

- [Presentation delivered to East Vancouver Port Lands committee](#) on December 8, 2020

The East Vancouver Port Lands committee requested that the presentation be posted on the project website page, and the presentation was posted after redacting project details that are not shared publically.

The table below outlines the input received through the public comment period and committee engagement, as well as the project team's response to the feedback gathered.



Before that could be done, Columbia Containers needed to upgrade its existing terminal and build a new grain elevator. Columbia Containers received the permit for the new grain trans-loading facility and silos in 2015 and have completed construction. Columbia Containers’ work to upgrade their facility is now complete, which allows the port authority to take the next steps toward completing realignment of the road and rail.</p> <p>The construction for this project is in the same area as construction activities for the Centerm Expansion Project and South Shore Access Project. The area is narrow and complex, presenting a number of challenges for construction and users of port roads. The port authority is writing to notify you that the Commissioner Street Road and Rail Realignment Project has submitted a request to conduct some construction activities outside of regular work hours.

As a Canada Port Authority, we have a mandate to ensure the Port of Vancouver is ready for Canada's growing trade. One of the ways we do this is by investing in and building essential infrastructure that connects consumers and businesses with the global marketplace, ensuring the supply of important and essential goods right across the country. As we respond to the extraordinary circumstances of COVID-19, the port remains open for business, and we continue our work to deliver on critical trade-enabling projects such as the Commissioner Street Road and Rail Realignment Project.

During this period, we expect the work will generate noise and some light from the project site, so we will implement noise and light reduction measures, including the following:

- Shrouding added to stationary equipment to contain the noise
- Activities that may result in more noise, such as excavation using a vacuum truck (hydrovac), to be done in the early hours of night shift (5:00 p.m. to 8:00 p.m.)
- Lights on construction site to face away from residences
- Silent pumps will be used during the bypass pumping for Metro Vancouver sanitary sewer relocation activities
- All noticeable noise (such as white noise back up beepers on equipment) will be well within 70 dB as per WorkSafeBC construction guidelines
