Committee renewal

The committee was established in summer 2019 for a timeframe of four years, aligned with the timing of the Centerm Expansion Project and other significant planned port development activities in the area. The committee's timeframe was set to expire in June 2023 and the port authority decided to extend the committee indefinitely. All committee members were asked to extend their service through the end of 2023 and begin a new term on the committee beginning January 2024. One key update is the addition of one representative each from Strathcona and Hastings-North BIA.

Rationale for renewing the committee included improving port-industry-community relationships, strengthening existing city-wide relationships, and creating positive interactions with the larger South Shore community.

Outreach

The SSCLC split its annual \$1,000 holiday donation between <u>Greater Vancouver Food Bank</u> and the <u>Lookout Housing & Health Society</u> (ARCH Program).

Events

In June, the committee was invited to participate in the port authority-led Climate and Air Quality Action Plan (CAQAP) session.

In July, the committee attended a joint harbour tour with the three other committees. The main focus was on the terminals, tenants and habitat restoration in Burrard Inlet and Indian Arm.

As part of its community investment program, the port authority was a sponsor of this year's Bard on the Beach. As a sponsor, the port authority received 40 tickets to one show and offered them to the four community liaison committees.
